Questions	Answers
Do resumes included in the Management Experience section under Tab 2.1 - Concept count towards to the page limit?	Yes.
Is there storage available for the units being offered within these tenders? If so how much is the fee per sq. foot and what's the estimated size of the space available?	There is no storage available in Terminal C. There is storage available in other terminals at \$50/SF/Year. Sizes vary as needed.
Item 3 on page 30 states, "Provide a representative sample of materials and colors to be used." Does the Airport require physical samples of the materials and colors or are electronic material boards sufficient?	Electronic material boards will satisfy the requirement.
Passenger Projection for 2020?	FY18 enplaned passenger projection is 33.6M. Anticipated annual passenger increase is approximately 2%.
F&B-1: Package A-15 – sweet snack – could that be smoothies?	Smoothies can be part of the menu, but should not comprise more than 20% of the menu.
F&B-3: C22 – can this be smoothie?	Smoothies can be part of the menu, but should not comprise more than 20% of the menu.
Please clarify the difference between convenience retail and travel essentials?	A Travel Essentials location is primarily last minute items, reading materials, and sundries. Convenience Retail locations provide a higher mix of food and beverage products in addition to the offerings at a Travel Essentials.

F&B-3: Does DFW anticipate that Package F&B -3 will have additional support space for storage and/or production?	There is no storage available in Terminal C. There is storage available in other terminals at \$50/SF/Year. Sizes vary as needed.
