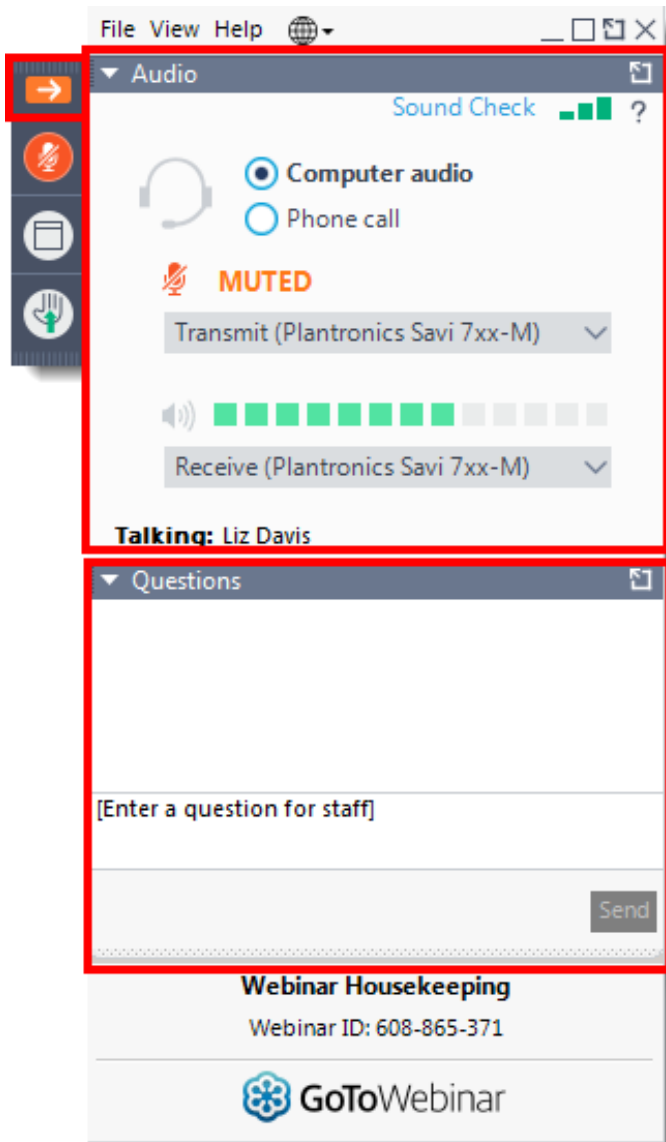

Relief Provided by DFW

The DFW Board has approved relief to in-terminal concessions and car rental companies projected to total \$26.4 million for January through September 2021

Relief includes:

- MAG, O&M, and Storage Rent relief for concessionaires and rental car companies
- Deferred percentage rent increases for applicable terminal concessionaires

CRRSA Grant to Airports for Concessions Relief

CRRSA grant is for rent relief provided by airports for concession occupancy or commercial use after December 27, 2020

Rent Categories:

- MAG
- Percentage Rent
- Facility O&M
- Ground Rent
- Storage

To accept the CRRSA grant, airports must provide relief to:

- In-Terminal Airport Concessions (109)
- On-Airport Rental Car Companies (9)
- On-Airport Parking Companies (1)

CRRSA will provide DFW a concession related grant of \$7,662,838 for Concession related relief and \$153,256 for administrative purposes.

CRRSA Grant to Fund a Portion of Relief Provided by DFW

Per FAA guidelines:

DFW will use the \$7.7 million grant to fund a portion of the approved Board relief

DFW intends to draw down this grant for relief provided during January 2021 through September 2021 after actual relief amounts are known.

- The first grant draw down is expected in mid May based on January through March actual results

FAA Allocation Guidance

Grant allocation must be *proportional* using a base-line time period

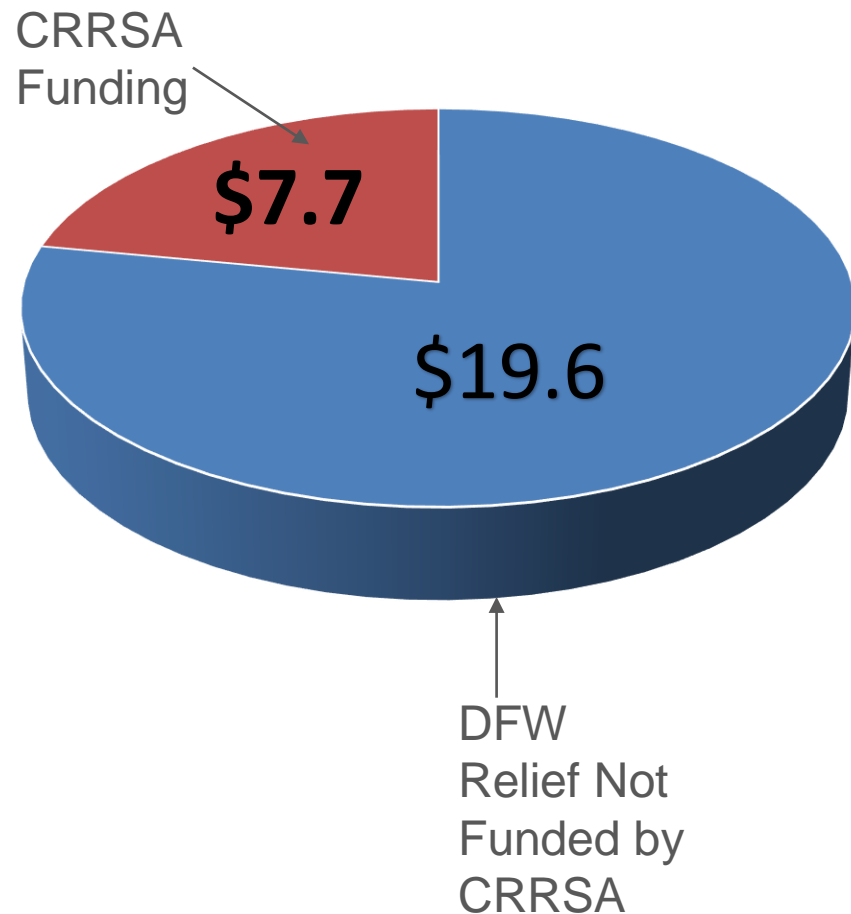
The allocation is based on rent due to DFW (MAG, percent rent, ground rent, O&M, and storage) by each entity as a percentage of the total rent due to DFW

The base-line time period must be relevant to the duration of the provided relief

DFW's base-line period will be January through September 2019 to be relevant to the period of relief...January through September 2021



Relief from January to Sept. 2021 projected to equal \$27.3M



There will be a small number of situations where the CRRSA amount exceeds the Board's approved amount

This additional relief will be ~ \$900K (\$387K for valet parking) and is incremental to the Board-approved \$26.4M in relief

Example

The grant allocation must be *proportional* basis at the level in which relief is provided...i.e., at the entity level

Most of the incremental relief will be credited to entities that have not received relief to date from DFW but are required so by CRRSA (approximately 20% of companies to receive additional relief – subject to change based on actual results)

Additional relief will be a billing credit after grant proceeds have been received

Eligibility Certification

Eligibility

Must be subject to agreement to remit rent after December 27, 2020

Concessions not paying rent after December 27, 2020 (i.e., entities that have terminated or announced termination of their leases) are not eligible

Sponsorships are not eligible for CRRSA relief

Concession entity must sign a certification that addresses Small Business Administration loans

Certification

In order to qualify for a CRRSA grant and be included in the base-line allocation, the concession must certify to the Airport that:

- It has not received a second draw or assistance for a covered loan under section 7(a)(37) of the Small Business Act (15 U.S.C. 636(a)(37)) that has been applied to rent or MAG costs; and
- It will not apply for a covered loan under section 7(a)(37) of the Small Business Act (15 U.S.C. 636(a)(37)) in order to pay rent or MAG costs.

If the concession has applied for such assistance, the entity must provide documentation showing that such assistance was not applied toward rent or MAG

Certification must be signed by a representative of the concessionaire with full knowledge of the finances of the entity and be authorized to make such representations and warranties on behalf of the entity

Signed under penalties of perjury and subject to penalties, including immediate termination of all rent relief or other assistance provided by DFW

5/21/2021	1 st draw down cash deposited
5/24/2021	Jan – March data transmitted to Finance for billing adjustments
5/25/2021	Finance sends out billings with first CRRSA adjustment
